# The Andrew Commemorative Fellowship

Closing date: 31 October

## Background

The Institution of Chemical Engineers has created the Andrew Fellowship to commemorate the prestigious work of IChemE Fellow Professor Syd Andrew, a distinguished expert in the field of catalysis.

The fellowship will provide up to four years funding (£10,000/y) to facilitate research into the science of the formulation of heterogeneous catalysts.

Fellowships usually commence on 1 March following the Award.

### Eligibility

Nominated Candidates must:

- 1. hold a PhD or have equivalent research experience and should normally be Early Career Researchers within the EPSRC definition (https://www.epsrc.ac.uk/skills/fellows/peerreviewprocess/whocanapply/)
- 2. hold a permanent or fixed-term contract or an offer of appointment in a University (fixed-term contract must cover a least the duration of the Fellowship)
- 3. provide a letter of support from the candidate's department
- 4. be able to demonstrate a meaningful relationship with an industrial partner and provide a letter of support from that partner with this application
- 5. be competent in written and oral English.

### Details of fellowship

The candidate will be expected, but not limited to:

- 1. carry out research into the field of the science of the formulation of heterogeneous catalysts.
- 2. develop a meaningful joint programme of research with the named industrial partner.
- 3. participate annually at the UK Catalysis Conference and assist IChemE in organizing relevant events throughout the Fellowship term
- 4. submit a series of reports as per the Monitoring timetable detailed at www.icheme.org/andrewfellowship/

NB. At the discretion of the awards committee, if the candidate's interests are seen to change from heterogeneous catalysis research or they cease to be employed at an accredited chemical engineering department, they may lose their Andrew Fellowship funding.

### Funding arrangements

The candidate will be granted an award of £10,000/y for four years in addition to whatever stipend or salary they might receive in their current or proposed appointment plus up to £5,000/y for travel, accommodation and limited equipment expenses in the same period.
