Introduction

Legislation – UK Retained EU Law Bill

A summary of the Bill and its status is provided by the S&LP SIG former Chair Andy Rushton.

The UK <u>Retained EU Law (Revocation and</u> <u>Reform) Bill</u> (REUL) is now the House of Lords' Committee Stage, having passed its second reading in the Lords (6 Feb 2023).

The Bill proposes to 'sunset' (i.e. revoke, at the end of 2023, unless Ministers act in the interim) a raft of 'retained EU law' unless that law is restated, replaced or updated through parliamentary or ministerial action.

The scope of this proposal is wide and appears to include major hazard legislation originating in the UK, but subsequently adopted and amended in the EU, such as:

- The Planning (Hazardous Substances) Regulations 2015
- Control of Major Accident Hazards Regulations 2015
- Offshore Installations (Offshore Safety Directive) (Safety Case etc) Regulations 2015

as well as much other safety legislation such as:

- Offshore Installations (Prevention of Fire and Explosion, and Emergency Response) Regulations 1995
- Dangerous Substances and Explosive Atmospheres Regulations 2002.

Many bodies have raised concerns, see for example: <u>RoSPA</u>, <u>health and safety coalition</u> joint statement.

Parliament has been advised that: 'HSE will continue to review its retained EU Law to seek opportunities to reduce business burdens and promote growth without reducing health and safety standards'. (Example Parliamentary written question response.)

However, neither HSE nor Ministers have made any public statement on which regulations will be restated, replaced or updated, nor indicated that there will be any delay of the 'sunset' (the Bill provides for Ministers to delay up to June 2026).

There are anecdotal reports that some regulations will be 'restated', but neither HSE nor Ministers have not yet confirmed that any of the regulations will continue into 2024.

IChemE S&LP SIG Committee members are raising awareness of this matter via professional Page 1 networks and via their <u>elected Westminster</u> representative (MP) and <u>devolved administration</u> representative, as applicable, and encourage S&LP SIG members to help raise awareness of the potential consequences with respect to process safety and loss prevention.

University Process Safety Workshops – 24 February 2023



On Friday 24 February 2023, the S&LP SIG ran Process Safety Workshops at:

- Brunel University London
- Queen Mary University of London
- London South Bank University

as a combined London event and for the first time at:

- Lancaster University; and
- The American University of Sharjah (AUS, UAE).

These were the first in person S&LP SIG University Process Safety workshops since 2019 and it was a great way for students and staff to interact and work with industry volunteers.

180 students attended from across the five institutions and 28 volunteers organised, presented and facilitated the workshops.

Brunel hosted the three London institutions and streamed the morning session to AUS. Multiple Brunel PhD students, Post Doctorate staff and technical support staff made this possible.

A huge thank you to all involved: University students, University staff and our enthusiastic and highly knowledgeable and skilled volunteers! We look forward to 2024!

MHC Process Safety Competence Project

SIESO Medal

The <u>SIESO Medal</u> was launched in 2019 to raise awareness of process safety among students. It is awarded to a team of up to six members for the best presentation of a major accident and the learning outcomes, with the judges looking in particular for novelty and inventiveness in the way the lessons are communicated.

Previous winners include an interactive training experience on Deepwater Horizon (<u>https://deepwaterhorizon.co.uk/</u>); a pop-up book outlining the 2005 Texas City explosion; and artwork depicting Flixborough.

As well as the medal, the winning team receive prize money of £750 and the opportunity to attend a process safety event for their medal presentation. All entrants will have their accompanying paper considered for publication in Loss Prevention Bulletin.

The competition opens for entry in February 2023 with the closing date being 31 October 2023.

Hazards 33

<u>Hazards 33</u> will take place in Birmingham, UK between 7 and 9 November 2023.
