What we have been up to

At the Global Congress on Process Safety in March 2023 it was announced that CCPS, ISC, European Process Safety (EPSC), Mary Kay O'Connor Process Safety Center (MKOPSC) and Fire and Blast Information Group (FABIG) are collaborating to deliver an annual "International Process Safety Week" to raise awareness in process safety. The first occurrence will be in December 2024. Stay tuned for more information.

The team attended the World Hydrogen Summit in May 2023. Alongside the Summit was the Center for Hydrogen



Safety (CHS) European Conference. I delivered a presentation on Leadership in Process Safety through the energy transition. The event focused on how traditional

process safety concepts can be applied to new sectors. This is a rapidly growing area where traditional industries can assist to prevent repeat incidents.

IChemE and AIChE have announced a Letter of Intent to collaborate on building a global alliance centered on the use of hydrogen. This goes beyond only safety. There will be some focus groups to map out what the future may hold.
