

Underpinning knowledge and understanding (UKU) panel - Chair

Volunteer Role Descriptor

1. Introduction

The Institution of Chemical Engineers (IChemE) is a registered charity and is incorporated by Royal Charter. As a registered charity, IChemE is regulated by the Charity Commission in England and Wales.

The UKU Panel reports to the Education Subcommittee (EdSub) and ratifies the assessments carried out of the underpinning knowledge and understanding of applicants for professionally qualified membership/registration who do not have exemplifying qualifications.

Further detail can be found in the committee Terms of Reference.

2. What you will be doing

- 1. Chair UKU panel meetings
- 2. Approve items for 'Chairs' delegated authority' in line with policy
- 3. Attend EdSub meetings; report to EdSub on issues, risks and opportunities related to UKU assessment, and update the UKU panel on EdSub matters, including the Business Plan
- 4. Liaise with EdSub when tasked and finishing group activities is required
- 5. Conduct periodic review of the panel and monitor the performance and effectiveness of UKU activities
- 6. Work with IChemE staff to ensure the committee (and related assessment activities) operates in a manner that is compliant with, but does not unnecessarily exceed, IChemE and Regulator regulations and guidance
- 7. Work with IChemE staff to handle exceptional issues
- 8. With IChemE staff, carry out succession planning for the UKU panel itself and the UKU assessor pool

All committee members shall promote and champion the approvals, qualifications, and registration activities of the Institution.

All committee members shall maintain confidentiality of all sensitive information.

A Vice-Chair can act when the Chair is unavailable or must withdraw due to a conflict of interest.

3. About you

The Chair should have significant experience of the assessment of UKU

The Chair should be a Chartered Member or Fellow of IChemE and hold CEng registration.

Experience of being a committee Chair is desirable but not mandatory.

All UKU panel members, other than IChemE employees, are volunteers of the Institution and are expected to adhere to the <u>Volunteer Conduct Principles</u> and must have regard to the <u>policies</u> and procedures set out in the <u>Volunteer Handbook</u>.

4. How you will benefit



There are many benefits to volunteering, including:

- personal satisfaction that your contribution helps to support a global network of chemical engineers
- extensive networking opportunities
- volunteering contributes to your continuing professional development (CPD)
- enhances your knowledge of chemical engineering and the opportunities it may offer

5. Time commitment

The UKU Panel usually meet 8-10 times a year. The meetings shall normally be held virtually and shall be scheduled to facilitate the attendance of the Committee's global membership.

The Chair is also an ex-officio member of EdSub, which usually meets quarterly.

6. Period of appointment

The term shall normally be **three years**. However, the Nominations Committee may vary the terms of office to ensure an appropriate balance of circulation and continuity of committee membership.

7. How to apply & appointment method

The Chair shall be appointed following an open process, with recommendations made by a selection panel to the Nominations Committee for ratification and quality assurance. The selection panel shall work actively to deliver a diverse and representative committee.
