What we have been up to...

Zsuzsanna ran an in-company online training course on Hazard Identification Techniques consisting of three modules, to a group of recent graduates working in the nuclear sector.

In January, Zsuzsanna ran a 2 day workshop in the Kingdom of Bahrain - A Masterclass in Managing and Measuring your Process Safety. She presented on Competency and Procurement at the 13th Professional Development Conference & Exhibition following the workshop.

Two webinars were run in February; one with Nancy Leveson on "How to learn more from accidents" and one with Mike Connell on "What Longford taught me about process safety". These are available to view on the ISC website.

Process safety competency

This project wrote a supplementary document which provides an example of the tasks and activities that could be undertaken to achieve the relevant level of competence in a few selected competency topics. Further topics will be added over time. The topics were from the Process Safety Competency Guidance Edition 2 and is now available to download from the ISC website.

What's next....

Zsuzsanna will run a 3 module online training course on Runaway reactions, starting from May, through three consecutive weeks. The course will help to better understand all aspects of chemical reaction hazards and managing the runaway reactions. The course draws upon a range of case studies from the chemical industry sector.

Safety Lore

New Case Study - Chemical Plant
